It was the beautiful voice of Judy Garland singing, "Meet me in St. Louis, Louis, meet me at the fair ...."

You are in for a great time in St. Louis, the Show-Me state and home to Scott Joplin, the prolific genius and ragtime composer. This is definitely the place to meet! Whether you are arriving from the north, south, east or west, St. Louis is where rich history and modern imagination collide.

The American Correctional Association is heading in August to the "Gateway to the West," to the city named after France's King Louis IX and founded in 1764 by French fur traders and located on the west bank of the Mississippi River. Steamboats first arrived in St. Louis in 1818, expanding the population and trade.

Today, St. Louis has what all modern American cities have: fine restaurants, great entertainment, and shopping, as well as top businesses, universities and services for every traveler, convention attendee and tourist who flies into the scenic St. Louis-Lambert



## 2017 E.R. Cass Correctional Achievement Awardee



#### James A. Gondles Jr.



James A. Gondles Jr., CAE, may be known best as executive director of the American Correctional Association, but this is just the tip of the iceberg when it comes to his career in corrections that has spanned more than 40 years.

Gondles served as deputy sheriff of Arlington County, Virginia, from 1972 until 1979, when he was elected sheriff. After being re-elected in 1983 and 1987, Gondles resigned in 1991 to fulfill his duties as executive director of ACA. However, this was not his first experience leading a correctional association, nor was it his first involvement with ACA. From 1987 to 1990, before he was selected as executive director, Gondles served as an elected Board member; from 1982 to 1987 as an elected member of ACA's Delegate Assembly; and from 1988 to 1990 as chair of ACA's Legislative Committee. Meanwhile, he also made time to be founding member and then president of the American Jail Association. Additionally, Gondles has held positions in the National Sheriffs' Association,

the Virginia Sheriffs' Association, the Metropolitan Washington Council of Governments and the Criminal Justice Advisory Council of George Mason University. He has been a member of the John Howard Association of Illinois Visitation Project Advisory Committee, the United Nations Non-Governmental Organizations Alliance, the American Society of Association Executives and the Fraternal Order of Police Lodge 35.

Gondles' dedication to improving his community has never ended with his job. For over 30 years, he was a member of the Kiwanis Club of Arlington, and he served on the Advisory Council for the Jamestown-Yorktown Foundation for eight years. In the past, he was involved with such organizations as the Arlington Salvation Army Board, Veterans' Memorial YMCA Board, Ashton Heights Civic Association, Committee of 100, Better Sports Club of Arlington, Arlington Chamber of Commerce, Good News Mission and Virginia United Methodist Conference. This dedication extended to the political arena (Gondles has served as state officer, campaign manager, finance chairman, county party chairman and national delegate to the presidential nominating convention) and even magazines and newsletters — he's written countless articles for *Police, The National Sheriff, American Jails* and ACA's very own *Corrections Today*.

Gondles earned a Bachelor of Arts in political science at Oklahoma City University and is a certified association executive with the American Society of Association Executives. He is married to Elizabeth F. Gondles, Ph.D., director of the association's Office of Correctional Health Care. Gondles has two children, Eric and Evan. Having received honors from the North American Association of Wardens & Superintendents and the Oklahoma Department of Corrections, to name just a couple, Gondles is now proud to be a recipient of ACA's E.R. 
